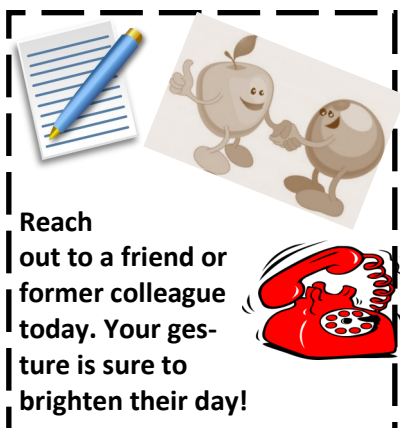

PSERS—In the News

PASR Statement on PSERS

Due to recent news about issues involving the Public School Employees Retirement System (PSERS), the Pennsylvania Association of School Retirees (PASR) is compelled to respond as it funds our pensions in retirement. Since PASR represents only retirees and not active members, issues involving alleged malfeasance at PSERS significantly impacts our members and their livelihoods.

PSERS has acknowledged that there is an active FBI investigation along with a federal grand jury investigation into its recent operations. At this time, there is no evidence or information leading to the conclusion that any pension has been placed in jeopardy.

Please note that PASR and PSERS are separate operations without any direct connection, therefore the investigation does not directly involve our organization

Reason for the Investigation

There is a shared risk provision with active (non-retiree) PSERS members under Pennsylvania State Law that is based on an investment “window” of nine years. If PSERS investment returns fall below 6.36 percent over that nine-year period, a shared risk provision increases the amount that public school employees, who were hired after July 1, 2011, pay into PSERS.

Originally PSERS certified that the nine-year return was 6.38 percent. Later, PSERS held a special meeting and changed that number to 6.34 percent which activated that shared risk provision.

News reports surfaced that indicated a possible investigation was underway at PSERS about the estimation of the nine-year investment return and the process it

took to reach that number. Recently, additional reports have indicated that the investigation goes beyond the process of the estimation. At this point it is speculation until there is a second party validation.

As a result of the pending investigations, PSERS has acknowledged hiring at least four outside law firms to represent them. Also, PSERS has acknowledged hiring an additional outside consulting firm to help with investments during the time their staff is under investigation. This will result in additional money being spent in addition to normal management and personnel costs. PASR will seek information on the impact of those additional expenditures.

Next Steps

The PSERS investigation will take time to run its course, and we must respect that process. It is important to note that the average federal grand jury investigation usually takes anywhere from 12 to 18 months to complete.

PASR will closely follow this issue and we are committed to providing factual updates to keep you informed as the investigation progresses. We are here to be a trusted resource and will continue to advocate on your behalf.

We sincerely appreciate our members and leaders who have reached out to us to comment and seek additional information. We rely on feedback from our members, and we will continue to be responsive.

HAVE YOU MET?

Art and history are lifetime pursuits for **Ken Hoak**, retired Solanco art teacher and department chair. In retirement Ken maintains his connections with both art and history through his many organizational affiliations. He is a member of the Echo Valley Art Group, an *invitation only* group consisting of just twenty-five members. His specialty is abstract sculpture. He is a former board member of the Lutheran Historical Society of Lancaster County and a Board Member of the Wolf Museum of Art and Music.

Ken is President Emeritus of Conestoga Historical Society and devotes much of his time to maintaining that collection. As a lifelong resident of Conestoga with ancestors dating back to 1730 in Conestoga Township, Ken is the third generation to reside on the same property. The Historical Society has a permanent display featuring toys from four generations of his family as well as a display of Easter Eggs from around the world. Ken's property covers 1 1/2 acres and has been featured on the Demuth Garden Tour.



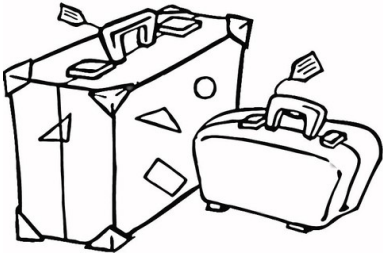
Ken also devotes much of his time to curating a collection of over 150 framed reproductions of great works from around the world that are on display at St. Paul Lutheran Church in Millersville. His work as Chairman of the Visual Arts Committee has led to the development of this collection over the past decades. One special sculpture created by Ken is on display at St. Paul. It is a welded metal and river rock sculpture "**David and Goliath**" which Ken gifted to the church.

Ken received a B.S. in Art Education at Kutztown State College and an M.A. from Columbia University Teachers College. He interrupted his work toward a PhD in 1968 to make a 3 1/2 month trip around the world, a trip that could not be duplicated today due to the changing political climate in the middle east and eastern Europe.

While teaching at Solanco, Ken also served as adjunct faculty at Millersville University teaching Foundations for Elementary Education, Stage Craft and Theater Design. As an adjunct professor at Elizabethtown College Ken taught sculpture. He also taught Art for Gifted Students at Lancaster County Art Association.

Far from being *retired*, Ken keeps busy, actively pursuing his passions.

Brian's work has been recognized by the Associated Press with the top honor for Enterprise Reporting in Pennsylvania and he's received several Emmy nominations. Brian has more than 30 years experience as a broadcast journalist, anchor and producer.

Brian was born and raised in Scranton, Pa. He graduated from Bishop Hannan High School in Scranton. He received his bachelor of arts in communications from Marywood University in Scranton.

Throughout his college years, Brian was an anchor/reporter for WARM 590 AM in the Scranton/Wilkes-Barre area. While on the radio, he was also the weekend weather personality on WBRE-TV in Wilkes-Barre. Upon graduation, Brian assumed a full-time position with WBRE as a reporter/anchor where he remained until 1995.

While at WBRE, Brian won several Associated Press Awards for Enterprise Reporting, Public Affairs and Spot News Coverage.

In November of 1995, Brian accepted the position of anchor and managing editor at KGAN-TV in Cedar Rapids, Iowa. Brian was the only local news anchor to travel to the scene of a tragic shooting at Columbine High School in Colorado and won an award from the Iowa Motion Picture Association for his work.

Brian is a member of the Board of Directors for Tabor Community Services in Lancaster. Brian has also served on the board of the Ronald McDonald House in Hershey.

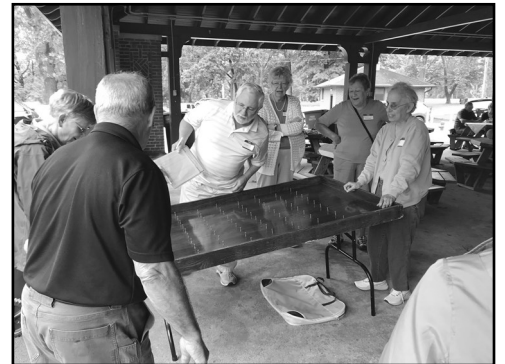
